# Should You Be Injured or Feel III

- Speak to your site contact immediately.
- Report all injuries to your site contact.

#### If You See a Fire

- · Hit the nearest call point.
- Leave any building by the nearest route and make your way to the assembly point.
- Only tackle the fire if you are trained and it is safe to do so.

#### **Alarms and Evacuation**

If the alarm sounds:

• Immediately leave the building and report to the evacuation point which is in the small car park opposite the office block.

#### On Arrival at Site

- Register your presence by signing in at the Main office.
- Inform your site contact of any medical condition that could affect feed or food safety.
- Park in the designated area.

# Getting Around the Site On foot

- · Keep to designated walk ways and crossings.
- · Avoid all vehicles and their operating area.
- · Hold hand rails where provided.

#### In your vehicle

- Keep to speed limit (Maximum 15 mph).
- · Comply with all signage.
- Hand held mobile phones must not be used whilst driving.
- · Wear seat belt at all times.
- · Do not leave keys in ignition.
- Drivers Safety, Follow One-Way systems

## **Personal Protective Equipment (PPE)**

- · Hi visibility in designated areas.
- Hearing / Respiratory Protection in designated areas
- Safety foot wear, non slip with protective toe caps.
- Hard Hat outside Cabs or offices
- Light eye protection
- Clean overalls or similar.
- Anti static clothing must be worn in zoned areas.
- Magnetic areas No Pace Makers

#### **Main Site Hazards**

There are a number of safety hazards of which you particularly need to be aware.

#### These include:

- · Large vehicles.
- · Asbestos.
- · Electricity. Explosive atmosphere potential.
- Process machinery.
- · Falls from heights.
- Slips, trips and falls.
- Dust

# Your Equipment Must be Safe

- Lifting equipment must be tested and have a current inspection certificate.
- Electrical equipment must be tested with in-date test stickers to verify this.

 All other equipment must be safe, legal, checked and fit for purpose.

#### **Safety Signs**

 Signage is used to indicate hazards and tell you what you must do. Follow at all times.

# The 5 Safety rules we must never break Follow road and pedestrian signage at all times. Keep a safe distance from any 2 working vehicle. Never enter a flat store if vehicles are operating inside. 3 Wait until the driver stops the engine or leaves the store. Wear the site mandatory PPE. Other PPE may be required. NOTICE WEAR **DUST MASK** Use the sheeting point provided. Hold handrails and follow safe systems of work.

### **Assess Your Task and Work Safely**

- No task should be started without a risk assessment and method statement if required.
- A permit to work will be required for some higher hazard tasks.
- Follow IGT's food/feed safety rules

• Your work area must be kept clean, tidy and orderly.

#### **Environmental Requirements**

- All wastes must be disposed of in the correct and legal manner. See your site contact for details.
- No waste or harmful substance may be poured into any drain or sink.
- Report any spillage immediately and contain it if safe to do so.

#### Food/Feed Safety and Illness

- · Smoking is banned unless in designated areas.
- No alcohol, glass or hard plastics may be brought on to site.
- If you have been suffering from any of the following within the last 48 hrs, you must notify your contact immediately: Infectious illness, diarrhoea, vomiting or any known gastrointestinal disease.
- Other specific requirements may apply, which you will be briefed on by your site contact as they apply to your task/work area.
- Advise your site contact if you have visited any food/feed storage or processing sites within the previous 2 days.
- Eating and drinking on site is only permitted within designated mess rooms.
